
**LAW ON
WHISTLEBLOWERS
PROTECTION SOON
TO BE ADOPTED IN
THE FEDERATION
OF BIH**

At the emergency session held on March 28, the FBiH Government adopted the FBiH Draft Law on Whistleblowers Protection. The Law has been sent to the Federation Parliament and will be the subject of two readings. The interested public will have the opportunity to provide their expert comments between the first and second readings. On behalf of the Anti-Corruption Network of Civil Society Organizations in Bosnia and Herzegovina - ACCOUNT, JUSTICIA / Srebrenik, the leading organization of the Sector Group Whistleblowers, participated in the development of the Draft Law. JUSTICIA presented the main aspects of this law to the monitoring team for development of the Draft Law at a joint meeting on March 26, 2018 in Sarajevo. All members of the team (**KAM / Zenica, CRCD / Doboj, ALDI / Goražde, CROA / Sarajevo, CGS / Livno, JUSTICIA / Srebrenik**) will participate in public discussions on the draft law before its adoption. The team will, inter alia, advocate for introducing a provision whereby those individuals who report corruption are exempted from paying court fees before the judgment is issued, in accordance with the laws governing court fees.

RESEARCH BY JUSTICIA: Seven institutions received corruption reports in the past period


The JUSTICIA Association conducted a research "Assessing the Effects of Anti-Corruption Regulations and Monitoring the Effects of the BiH Law on Protection of Whistleblowers", which included 60 state institutions. Among other findings of the survey, it was determined that 7 institutions received reports on corruption cases in the past period, and that 5 of them received reports from citizens. The most common reasons for such a small number of reports, indicated by the respondents, are the fear of retaliation, mistrust in the mechanisms of protection, or absence of corruption in their institutions.

TRAINING

On March 27 and 28, 2018, Education for judges and prosecutors from Bosnia and Herzegovina in the field of public procurement was held in Doboj. The training was organized by USAID's projects - Justice Project in BiH and ACCOUNT in tandem, as well as with the entity - level Education Centers for Judges and Prosecutors. Through the lectures on "Public procurement in BiH - Identification of corruption in public procurement", judges and prosecutors had the opportunity to learn how to achieve successful accusations in cases of corruption in public procurement, what are the indicators and the most common forms of corruption, and what the priorities in the investigations are. Representatives of the Public Procurement Agency of BiH, the Office for the Review of Appeals, prosecutors of the Special Prosecution Office of Macedonia and the judges of the Supreme Court of Cassation from Serbia took part in the training.

THIRD CYCLE OF FINANCING OF MONITORING TEAMS - SELECTED LEAD ORGANIZATIONS

After evaluation of the submitted project proposals, the following are the best evaluated organizations that have been selected as the leaders in the areas of:

- Public Procurement - **Association Justicia / Srebrenik**
- Education - **Women's Rights Center / Zenica**
- Whistleblowers Protection - **Center for Civil Society Development / Dobož**
- Health - **Foundation for Development and Democracy / Sarajevo**
- Employment - **Center for Civic Cooperation / Livno**

The third funding cycle will be awarded for a period of six months, starting no later than April 2018 and ending in October 2018.

Anti-Corruption Youth Forum Held

The first Anti-Corruption Youth Forum Held in Mostar

On March 28, 2018, the first Anti-Corruption Youth Forum was held in Mostar on "The Impact of Anti-Corruption Education on the Change of Youth Perception on Corruption." The Forum was organized by the Center for the Development of Youth Activism (CROA), the purpose of which was to open a youth dialogue on the perceived level of corruption in education in BiH; in which areas it appears, and in what way it is manifested, but also how anti-corruption education affects the perception of youth on corruption.

In an introductory speech, the CROA Director, Zafir Šišić, explained the main idea of the project of investigating the perception of corruption in education in Bosnia and Herzegovina.

Panelists, representatives of educational institutions, representatives of the government institutions and non-governmental sector, representatives of the Youth Council as well as students pointed to a multitude of problems in the education system, starting from the increasingly frequent occurrence of numerous irregularities (bribery, corruption) to the curricula in which the final goals of education are not clearly defined, the problems faced by teaching and scholarly staff in the educational process, and the lack of unified codes of ethics in educational institutions in BiH.

“Mini Detector of Corruption”

41% of young people are intolerant to corruption

Corruption does not exist in their universe. They represent a classical example of a “nerd”, someone who follows the rules and laws blindly, does not engage in calculations, does not seek other solutions, but strictly adheres to moral principles and observes the rules. These are highly moral persons, consistent, persistent, totally objective. They are always trying to fight for truth and justice.

31% of young people Intolerant to corruption

These are people who respect the rules and their behavior in corrupt situations is in accordance with the general norms. People who attribute greater importance to moral values do not tolerate injustice, do not accept the idea that corruption is an integral part of everyday life simply because "they all do it" and because "it cannot be different".

15% of young people on the verge of losing relevant and normative orientations

Their reaction to the social state is the adoption of various forms of deviant behavior, within which it is difficult to draw the line between the socially acceptable "circumvention" of regulations, the relativizing of moral norms and the open practice of immorality and corruption.

13% of young people accept corruption as an everyday phenomenon

Although they have a certain negative opinion on corruption, they do not have too many problems to make use of particular advantages of a situation. They are lazy in terms of taking a personal attitude, they are likely to adapt to the environment, giving socially acceptable and desirable answers, and they follow a line of lesser resistance. They function according to the principle of service for service, putting their needs to the forefront. They look for getting the best for themselves, regardless of possible long-term consequences.

Strengthening the capacity of local communities to prevent corruption

HELSINKI COMMITTEE FOR HUMAN RIGHTS

As part of the project "Strengthening the Capacities of Local Communities for the Prevention of Corruption", implemented under the Small Grants Program of the Anti-corruption Network in BiH - ACOUNT, after establishing cooperation with representatives of local administrations in Zavidovići, Banovići and Domaljevac, representatives of Helsinki Human Rights Committee joined the Working Group for meetings and participated in the preparation of the local action plans for the prevention and fight against corruption in these municipalities.

In March, the third meeting of the Working Group in the Banovići Municipality was held, where the preparation of the Action Plan for the Prevention of Corruption is in the final stage.

ICVA / ALDI

The partner organizations Initiative and Civil Action (ICVA) / Sarajevo, ALDI / Gorazde, and the Government of the Bosnia-Podrinje Canton, engaged in fight against corruption, organized expert discussion and presentation of guidelines / regulations for preventing corruption in public health institutions on March 13, 2018.

This discussion is part of an initiative for cooperation and joint action of relevant institutions and civil society organizations in improving the institutional system for prevention of corruption in the health sector.

On that occasion, ICVA presented a draft of a rule book / policies and procedures for the prevention of corruption in health institutions in Sarajevo and Zenica-Doboj cantons. During the discussion, the participants had the opportunity to provide suggestions and proposals in order to get acquainted with the advantages of introducing such a rulebook.

On March 6, 2018, Čapljina adopted the Action Plan for Combating Corruption at the local level (2018-2023).

KAM ZENICA

After completing the quantitative and qualitative analysis of the self-assessment of the areas that are exposed to corruption and workshops on the preparation of action plans for the fight against corruption based on the analysis, the Working Groups of the Travnik and Žepče municipalities have started the preparation of the Action Plans, while Visoko is the first municipality in 2018 that adopted the Action Plan for Prevention of Corruption. The consequences of corruption in practice include poor public services, increased social polarization, inefficiency in public services, low investment in the municipality, reduction of economic growth, inadequate treatment of citizens by municipal officials. Although there is no a unique recipe for combating corruption at the local level, the development of anti-corruption action plans has proven to be a good preventative format.
